

#### Summary of Proposed Changes for the 2015/2016 NCCC Competition Program (Rulebook)

Finally, children age 12 and older can ride-along in low speed autocrosses. An NCCC rule restricting the age to 16 had long disappointed parents and grandparents, not to mention the kids, in preventing them from experiencing the thrill.

Our own club member, **Jeff McCutcheon**, is the author of the original request for a National rulebook change. Kudos to Jeff for persevering through, what appeared to be, insurmountable odds.

Below is the summary, provided by Rik Noring, of all the rule changes effective January 1, 2015.

See #7 specific to ride-along ages.

- 1) Two-year rulebook.
- 2) Consolidate safety information into one section in Chapter 1.
- 3) Incorporate applicable clarifications from 2013/2014.
- 4) Various grammatical changes to align the rulebook with the Competition database.
- 5) Allow sanctioned events on Convention weekends in the case of a shortened convention.
- 6) Change the flier requirements to allow for written location description in lieu of maps and to include insurance coverage information
- 7) Allow competitors to ride as passengers at low speed events (with appropriate approval and waivers).

#### 2.2.8. PASSENGERS

In order to encourage future participation and to orient future drivers, passengers are encouraged to ride with competitors during Low Speed Autocross events. The following restrictions apply to passengers in autocross events:

- 1. Passengers are not allowed during High Speed events under any circumstances except during parade laps. (1/15)
- 2. Passengers must meet the competition eligibility requirements of Section 1.7.1 of the NCCC Rule Book.

Passenger minimum ages are as follows: (01/15)

A. High Speed Autocross Parade Laps: 16 years old

B. Low Speed Autocross: 12 years old C. Rallye (Navigator): 9 years old D. Funkhana (Navigator): 16 years old

Passengers under 18 years old MUST comply with all waiver requirements as indicated in Section 1.8.1.

#### Continued......

- 8) Allow competitors to ride with novices and vice/versa.
- 9) Allow rack and pinion steering in Group 3.
- 10) Allow coil over springs in Group 3.
- 11) Allow for some "loosening of rules" in Group 1S and 1, such as aftermarket cold air intakes, aftermarket shifters, crossover pipes, as well as some reliability items.
- 12) For Group 1S and Group 1 wheels, allow updating/backdating within class and +/- 1" of width and + inch of diameter for 82 and older cars.
- 13) For Group 1S and Group 1 wheels, allow updating/backdating within and +/- 1" of width and +/- inch of diameter for 84 and newer cars.
- 14) For the purposes of competition, awards, and points, class F and G shall be known as F/G in Groups 1S, 1, &2.
- 15) For the purposes of competition, awards, and points, class J and K shall be known as J/K in Groups 1S, 1, &2.
- 16) Move the C6 Z06 carbon edition and C6 Z06 with Z07 option into class M.

The above summary may not reflect the exact language to be found in the proposed Rulebook. Refer to the red-line version of the proposed Rulebook for specific details.

#### **Technical Corner –Re: Recall Notice**

**SUMMARY:** 

General Motors has decided that a defect which relates to motor vehicle safety exists in model year 2005-2007 Chevrolet Corvette vehicles. On these vehicles, when the engine is warm, the underhood bussed electrical center (UBEC) housing will expand, causing the headlamp low-beam relay control circuit routed wire to bend slightly. After the wire is repeatedly bent, it can fracture and separate. When this occurs, the low-beam headlamps will not illuminate. As the UBEC housing cools and contracts, the low-beam headlamp function may return. This condition does not affect the high-beam headlamps, marker lamps, turn signals, daytime running lamps or fog lamps.

**SAFETY RISK:** 

Loss of low beam headlamps when they are required could reduce the driver's visibility, increasing the risk of a crash. **REMEDY:** 

Dealers are to replace the UBEC.

#### **GREAT NEWS -**

#### Window Stickers & the Blue Devil

**Window Stickers** and build sheets from 1981 to the present, after a brief hiatus, are again available from the Museum's Library & Archives. The window stickers including build sheets can be purchased at \$75 for members and \$90 for non-members; lamination is available for \$5 additional per item.

The ZR1 Blue Devil, a victim to the Skydome sinkhole February 12<sup>th</sup>, was unveiled at the Specialty Equipment Market Association (SEMA) show held in Las Vegas, November 4-7. In its recovered condition, it had been displayed at the Museum from March 3<sup>rd</sup> through the Labor Day 20<sup>th</sup> Anniversary Celebration, and then returned to Chevrolet for restoration. Damage included: cracked carbon-fiber body parts and a broken passenger-side rocker panel; damaged passenger front fender as well as cracks in both doors; cracked windshield, hood window glass and passenger headlamp assembly; bent rear control arms on driver door; and cracked oil lines to the supercharged LS9 engine's dry-sump oiling system.

Six weeks after work began, the restored ZR1was started for the first time at the GM Heritage Center. After the Museum's Skydome repairs are concluded by July 2015, the Blue Devil will be on display there. The one-millionth Corvette and the 1962 black roadster will be restored next year. The remaining 5 Corvettes will not be restored, but are on display at the Museum.

#### A Blast from the Past – June 1969 Newsletter Article By Mary Moorehouse "The Crystal Park Hillclimb"
