As a follow-on to the bylaws and standing rules changes, approved by the membership at the January meeting; Robert Miskowitch has submitted the following change proposals, which will be presented, discussed at voted on at the February meeting.

**Bylaw Change Proposal:**

**Article II, 1.2 ENTHUSIAST MEMBER**

It is recommended that a path for Enthusiast members to become full members be identified. Therefore, it is recommended that paragraph C be added.

**Current Version: N/A**

**Proposed Version:**

C. Upon satisfying the requirements of full membership outlined in Article II, paragraph 1.0, an Enthusiast member may change their membership status to full membership by paying the difference of annual dues (including NCCC and RMR dues).

**Standing Rules Change Proposals:**

**1.0 FINANCIAL POLICY, A. Dues**

For the purpose of consistency, it is recommended the annual dues for Enthusiast members be identified, as are the dues for other membership types. Approval will require the renumbering of two subsequent paragraphs to (4) and (5) respectively.

**Current Version: N/A**

**Proposed Version:**

(3) CSCC Enthusiast membership \$10.00 annually.

**5.0 PUBLICATIONS POLICY, D. Advertising**

It is felt the term "Associate members" in subparagraph (2) is unnecessary and should be removed for clarity purposes. By only using the term "Club members," it would allow for inclusion of all members, regardless of membership type.

**Current Version:**

(2) Club members or Associate members may advertise their Corvette and Corvette related personal property for sale free of charge.

**Proposed Version:**

(2) Club members may advertise their Corvette and Corvette related personal property for sale free of charge.

## EXHIBIT REMODEL & C8 AWARDS

### PERFORMANCE GALLERY EXHIBIT REMODEL

Thanks to a private funding donation, the NCM has embarked on a major exhibit remodel. It will bring one of its earliest displays up to date with a design that truly reflects the sleek and stylish nature of America's favorite sports car.

The Performance Gallery is one exhibit that's been around since the building's grand opening in 1994. In the early days an elevated racetrack gave display cars a sense of motion and being on the grid, but difficulties with the change-out of vehicles dictated eventual removal of the racetrack. Over the years, the exhibit space has housed an interactive pit crew challenge, educational driving simulator, and various artifacts; but according to Derek Moore, Director of Collections, "it's time for an overhaul!"

The remodel will have a clean look, showcasing historic racing videos and stories about each car on display. The concept is to have a projection of each car, as well as digital labels, allowing visitors to learn more through an interactive experience. Moreover, rather than remove or paint over the existing wall's racing mural, a secondary wall will be installed thereby keeping the original mural protected and intact behind the scenes.

The exhibit is planned to open in late March 2020, with an official ribbon-cutting ceremony during the Michelin Bash April 23-25.

### C8 AWARDS

*Car and Driver* magazine has released its 2020 list of "10Best" winners, representing the smartest, most entertaining vehicles. The editors pick the 10 winners following an exhaustive 2-week evaluation. The 2020 Corvette made the "10Best" list, competing with 92 cars, trucks, SUVs and vans. Moving the engine to the middle has not only taken Corvette's performance to new heights but has elevated it to super car status.

*Edmunds*, an American online resource for automotive information, has awarded the C8 Corvette Stingray as the Best Sports Car in its 2020 "Top Rated Awards" for its stellar performance and value. In its transformation to a mid-engine sports car with the kind of balance, poise, and agility one would expect from an exotic supercar, it remains usable on the commute at a low base price.
